Most of the development translation work of TWB is delivered through the Workspace, a managed, crowd-sourced community connecting qualified translators directly with and to TWB's non-profit partners. The Workspace allows swift and accurate translation of educational materials, medical information and humanitarian documents, vital information for needy populations in their own languages. During the fiscal year, 7 million translated words, with an estimated value of \$1,392,000, were provided to vetted, non-profit partners through Workspace. Over 3,400 volunteer translators were registered on the Workspace and working on assignments in 130 language pairs for over 200 humanitarian organizations.

To better support non-governmental and aid organizations in communicating with vulnerable communities, TWB continues to financially support TWB Kenya, an independently registered, non-profit translation and program management center in Nairobi, Kenya. The facility operates a team of professional translators, program managers and language trainers. This fiscal year, TWB Kenya continued to support regional NGO's through its translation and project management services.

During the fiscal year, TWB deployed its Words of Relief (WoR) crisis relief translation network in response to crises such as the Nepal earthquake, the Burundi refugee crisis and the European refugee crisis. WoR is intended to eliminate linguistic barriers that can impede vital response and relief efforts. Through WoR, TWB proactively provided crisis and disaster messages in key languages, of affected populations, before, during and after crises occurred. This involved developing a network of diaspora translators who are trained to assist immediately upon activation of a crisis response, and using technologies to ensure rapid, high quality translation response from translation teams and better dissemination of critical content through partners.
